WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides, in part, that every local government unit shall exercise powers necessary for its efficient and effective governance, as well as those essential to the promotion of the general welfare;

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each Local Government Unit shall have a comprehensive, multi-sectoral development plan to be initiated by its development council and approved by the Sanggunian Bayan;

WHEREAS, the Taytay Development Council (TDC) shall assist the Sanggunian Bayan (SB) in setting the direction of development efforts within the municipality;

WHEREAS, there are several priority projects, programs, and activities that require fund allocation for implementation;

WHEREAS, after thorough deliberation, the members of the Taytay Development Council (TDC) unanimously approved the realignment of One Hundred Thirty Million Twenty-Eight Thousand Three Hundred Twenty-One Pesos and Fifty-Eight Centavos (Php 130,028,321.58) from PPAs under the 20% Development Fund of the 2025 Annual Budget of Taytay;

WHEREAS, the fund amounting to One Hundred Thirty Million Twenty-Eight Thousand Three Hundred Twenty-One Pesos and Fifty-Eight Centavos (Php 130,028,321.58) subject to realignment, was taken from the following appropriations:


RESOLVED FURTHER, that a copy of this Resolution be furnished to all concerned for their information and appropriate action.
