WHEREAS, the Philippine Normal University (“PNU”) is the designated National Center for Teacher Education pursuant to Republic Act No. 9647, the mandate is to provide programs for professional development of teachers, including the Licensure Examination for Professional Teachers (“LEPT”) Review Program under its College of Alternative and Lifelong Learning (“CALL”);

WHEREAS, the Local Government Unit, through the Smile Taytay Training Institute (“STTI”), is committed to capacitating aspiring and current educators within the municipality, in alignment with its thrust of supporting inclusive and quality education;

WHEREAS, both parties recognize the need to implement a three-day ONLINE LEPT Final Coaching Program on September 6, 7, and 13, 2025, to prepare teacher beneficiaries from Taytay for the upcoming LEPT examination;

WHEREAS, for and in consideration of the foregoing, the parties agree to the following terms and conditions of the memorandum of agreement;

WHEREAS, the Municipal Government of Taytay shall sign and enter into a Memorandum of Agreement with the Philippine Normal University, for the implementation of the program to all Taytayeño constituents;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños through prompt and utmost public service, this Sangguniang Bayan Resolution is being issued;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE NORMAL UNIVERSITY FOR THE FINAL COACHING PROGRAM FOR TEACHER BENEFICIARIES, REPRESENTED HEREIN BY ITS UNIVERSITY PRESIDENT, DR. BERT J. TUGA, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement with Philippine Normal University be ratified first by the Sangguniang Bayan before its full implementation.


