DE LEON, MPA, TO ENTER AND SIGN WITH THE PHILIPPINE STATISTICS AUTHORITY FOR THE DATA TURN-OVER AGREEMENT REPRESENTED HEREIN BY ITS UNDERSECRETARY, CLAIRE DENNIS S. MAPA, PhD, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, Republic Act (“RA”) 11315 provides that the cities and municipalities can maintain their Community-Based Monitoring System (“CBMS”) database for local-level planning and program implementation, and the Philippine Statistics Authority (“PSA”) shall receive and store all aggregated data gathered by the cities and municipalities to create a national CBMS databank;

WHEREAS, the CBMS was established and instituted in every city and municipality as an economic and social tool for the formulation and implementation of poverty alleviation and development programs that are specific, targeted, and responsive to the basic needs of each sector of the community pursuant to RA No. 11315 or the Community-Based Monitoring System Act;

WHEREAS, the PSA, as the lead agency in the implementation of RA No. 11315, shall undertake measures to ensure the integrity and safety of the gathered information against unnecessary leakage and access by unauthorized persons;

WHEREAS, the Municipal Government of Taytay shall sign and enter into a Data Turnover Agreement with the PSA, for the implementation of the transmission and receiving of data;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the turnover of data will strengthen the mission of the Municipal Government to meet the needs its inhabitants;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO ENTER AND SIGN WITH THE PHILIPPINE


STATISTICS AUTHORITY FOR THE DATA TURN-OVER AGREEMENT REPRESENTED HEREIN BY ITS UNDERSECRETARY, CLAIRE DENNIS S. MAPA, PhD, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the duly signed Data Turn-over Agreement be ratified first by the Sangguniang Bayan before its full implementation.


