WHEREAS, in pursuance of the above mandate, the ECCDC aims to further enhance the provision of quality home-based and center-based ECCD programs in partnership with stakeholders;


WHEREAS, the ECCDC intends to establish National Child Development Centers (NCDCs) including the provision of contents and teacher to serve as its laboratory of the different modes of delivery of center-based ECCD programs;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby AUTHORIZES HONORABLE MAYOR ALLAN MARTINE S. DE LEON, MPA, TO SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF TAYTAY, THE MEMORANDUM OF AGREEMENT (MOA) WITH EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCDC) REPRESENTED BY DR.
