WHEREAS, the Office of the Barangay Secretary of Barangay Dolores submitted to the Sangguniang Bayan for review a copy of Barangay Ordinance No. 18 s. 2025 entitled: “An Ordinance Institutionalizing the Dolores Rehabilitation Facility and Dolores Special Education (SPED) Center as part of the Barangay Health Services, Providing for its Permanence and Ensuring Continuity of Services”;

WHEREAS, the aforementioned Ordinance has undergone the review of the Committee on Rules, Resolutions, and Ordinances to check on the merits of the pronouncement from the Barangay’s Local Government Unit;

WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said Ordinance as prescribed in the adopted Committee Report of the Committee on Rules, Resolutions, and Ordinances;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby APPROVES IN REVIEW THE BARANGAY ORDINANCE NO. 018 S. 2025 OF BARANGAY DOLORES.
