WHEREAS, Section 438(a) of RA 7160 otherwise known as the Local Government Code of 1991 states that: "A Sanggunian Kabataan chairman shall, upon certification of his election by the Comelec and during his tenure of office is elected as pederasyon president, serve as an exofficio member of the Sangguniang Bayan, without need of further appointment";

WHEREAS, the position of Sangguniang Kabataan Federation President has been vacated after former S.K. Fed. Pres Janinah Olivienne D.L. Mercado resigned on March 26, 2025;

WHEREAS, SK Chairperson Lucia Marie D. Alcantara of Barangay Sta. Ana was elected as the New SK Federation President and shall assume the Office after she took her oath;

WHEREAS, the new SK Federation President, serving as an Ex-officio Member of the 12th Sangguniang Bayan shall assume the committee chairpersonship of the previous SK Federation President, namely: the Committee on Youth and Sports Development and the Committee on Information and Communications Technology, likewise she shall assume all other committee membership of the previous SK Federation President;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby ACCEPTS LUCIA MARIE D. ALCANTARA AS AN EX-OFFICIO MEMBER OF THE 12TH SANGGUNIANG BAYAN OF TAYTAY REPRESENTING THE SANGGUNIANG KABATAAN FEDERATION.
