DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT AND MUTUAL NON-DISCLOSURE AGREEMENT WITH PHILIPPINE HEALTH INSURANCE CORPORATION, REPRESENTED HEREIN BY ITS VICE PRESIDENT, BERNADETTE C. LICO, M.D., IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution states that, "the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers";

WHEREAS, Section 2 of the Republic Act No. 10606, otherwise known as the "National Health Insurance Act of 2013" mandates that, "it is hereby declared the policy of the State to adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health, and other social services available to all the people at affordable cost and to provide free medical care to paupers. Towards this end, the State shall provide comprehensive health care services to all Filipinos through a socialized health insurance program that will prioritize the health care needs of the underprivileged, sick, elderly, persons with disabilities (PWDs), women and children and provide free health care services to indigents";

WHEREAS, Section 4, Rule I, Title III of the Implementing Rules and Regulation of RA No. 7875 As Amended, otherwise known as the "National Health Insurance Act of 2013" mandates that, "All Filipinos shall be mandatorily covered under the Program. In accordance with the principles of universality and compulsory coverage enunciated in Section 2(b) and 2(l) of the Act, implementation of the Program shall ensure sustainability of coverage and continuous enhancement of the quality of service. The Program shall be compulsory in all provinces, cities, and municipalities nationwide, notwithstanding the existence of LGU-based health insurance programs. The Corporation, DOH, LGUs, and other agencies including Non-Governmental Organizations (NGOs) and other National Government Agencies (NGAs) shall ensure that members in such localities shall have access to quality and cost-effective health care services";

WHEREAS, Section 5(a)(3), Rule I, Title III of IRR of RA No. 7875 As Amended, otherwise known as the "National Health Insurance Act of 2013" states that, "all other workers rendering services, whether in government or private offices, such as job order contractors, project-based contractors and the like";

WHEREAS, the Municipal Government of Taytay shall enter into a Memorandum of Agreement (MOA) and Mutual Non-Disclosure Agreement (MNDA) with Philippine Health Insurance Corporation, to provide social protection and social health insurance for Taytayeño constituents;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the negotiation of MOA and MNDA with the Philippine Health Insurance will strengthen the mission of the Municipal Government to meet the needs of its inhabitants;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT AND MUTUAL NON-DISCLOSURE AGREEMENT WITH PHILIPPINE HEALTH INSURANCE CORPORATION, REPRESENTED HEREIN BY ITS VICE PRESIDENT, BERNADETTE C. LICO, M.D., IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that copies of this Resolution be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
