WHEREAS, the Municipality of Taytay expresses its gratitude to the COMELEC, all the volunteer groups, and government employees involved in the conduct of a successful and peaceful 2025 Midterm Local and National Elections;

WHEREAS, the Sangguniang Bayan has received several complaints and concerns from constituents regarding precinct assignments that are significantly distant from their respective areas of residence;

WHEREAS, specific areas of concern include the following:

- Residents of *Pugad Lawin* Brgy. San Juan assigned to *Rosario Ocampo Elementary School (ROES)* who may be reassigned to *Taytay National High School*;
- Residents of *Bangiad* Brgy. San Juan assigned to *Kapalaran Elementary School* who may be reassigned to *Cresdaville Elementary School*;
- Residents of *Pag-asa Floodway* Brgy. Sta. Ana assigned to the *University of Rizal System (URS) - Taytay Campus* who may be reassigned to *Antonio C. Esguerra Integrated School*; and
- Residents of *Purok 17* Brgy. San Juan assigned to *Manuel I. Santos Memorial National High School* who may be reassigned to *San Francisco Elementary School*.

WHEREAS, such assignments may pose challenges in exercising the right to vote, especially among senior citizens, persons with special needs, and other vulnerable sectors;

WHEREAS, the Sangguniang Bayan respectfully requests that the Commission on Elections (COMELEC) conduct a review and possible reassignment of affected cluster precincts to polling places that are closer and more accessible to the communities concerned;


WHEREAS, it is further requested that COMELEC ensure that precinct clustering does not exceed the average capacity to prevent overcrowding and longer queuing times, thus promoting a more orderly and efficient voting process;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby HUMBLY REQUESTS THE COMMISSION ON ELECTIONS CHAIRPERSON GEORGE ERWIN M. GARCIA THROUGH COMELEC TAYTAY ELECTION OFFICER, RHODORA G. AQUINO-YANES, J.D., TO REVIEW AND RECONSIDER FURTHER ADJUSTMENTS ON PRECINCT ASSIGNMENTS ON SEVERAL POLLING PLACES WITHIN THE MUNICIPALITY OF TAYTAY, RIZAL.

RESOLVED FURTHER, that a copy of this Resolution be furnished to all associated offices and parties concerned for their information and appropriate action.
