Ana submitted to the Sangguniang Bayan for review a copy of Barangay Ordinance No. 020 s. 2025 entitled: "An Ordinance Creating the Oplan Kapayapaan Program and Designating Personnel and Community Volunteers to Assist in the Maintenance of Peace, Order, and Public Conduct";

WHEREAS, the aforementioned Ordinance has undergone the review of the Committee on Rules, Resolutions, and Ordinances to check on the merits of the pronouncement from the Barangay's Local Government Unit;

WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said Ordinance as prescribed in the adopted Committee Report of the Committee on Rules, Resolutions, and Ordinances;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby APPROVES IN REVIEW THE BARANGAY ORDINANCE NO. 020 S. 2025 OF BARANGAY STA. ANA.

RESOLVED FURTHER, that copies of this Resolution and the approved Committee Report of the Committee on Rules, Resolutions, and Ordinances be furnished to the Sangguniang Barangay concerned for their information and appropriate action.
