WHEREAS, Section 3(“a”) of the Republic Act 10588, also known as the Palarong Pambansa Act of 2013, states that one of its objectives is to institutionalize the Palarong Pambansa as the premier national sporting event of the country under the Department of Education (DepEd) as venue for talent identification, selection, and recruitment of student athletes;

WHEREAS, the 65th Palarong Pambansa, themed “Nagkakaisang Kapuluan” which took place in Ilocos Norte, gathered student-athletes from 17 athletic associations representing the 17 regions of the Philippines to compete in various sporting events;

WHEREAS, after the culmination of Palarong Pambansa 2025, held at Centennial Arena, Laoag City, and other venues within the host city from May 24 to 31, several Atletang Taytayeyños from the different DepEd Taytay schools, representing CALABARZON won the following medals from various competitions:


