WHEREAS, the Municipal Engineering Office, upon the request of Ms. Maria Ellen M. Losito, Principal of Sitio Simona Elementary School, conducted a thorough ocular inspection last October 2, 2024 on the existing old One-Storey Four Classroom School Building and has gauged that the building is eligible for demolition and eventually be replaced with a multi-level edifice;

WHEREAS, due to the increasing number of students, there is a prayer from the administration of Sitio Simona Elementary School to construct a Multi-level School Building to accommodate the growing number of enrollees in San Isidro;

WHEREAS, the Local Government Unit of Taytay has insufficient funds for the construction of a multi-level school building thus entails seeking the support of the Provincial Government in responding to the clamor and request of the alumni, teachers and parents of the pupils of Sitio Simona Elementary School;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby HUMBLY REQUESTS THE HONORABLE GOVERNOR NINA RICCI YNARES TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A MULTI-LEVEL YNARES TYPE SCHOOL BUILDING AT SITIO SIMONA ELEMENTARY SCHOOL IN TAYTAY, RIZAL.
