A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH LAND TRANSPORTATION OFFICE TAYTAY, REPRESENTED HEREIN BY ITS CHIEF OF OFFICE, DYONN T. DACPANO, FOR ASSISTING IN THE DISTRIBUTION OF PUBLIC MOTORIZED TRICYCLE FOR HIRE LICENSE PLATES IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL, AND FOR OTHER PURPOSES

WHEREAS, Section 16 of Republic Act ("R.A.") No. 7160, otherwise known as the "Local Government Code of 1991", mandates that, *"every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants"*;

WHEREAS, Section 458(3)(vi) of Local Government Code of 1991 states that:

"(3) Subject to the provisions of Book II of this Code, enact ordinances granting franchises and authorizing the issuance of permits or licenses, upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the city and pursuant to this legislative authority shall:

XXX

(vi) Subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city";

WHEREAS, the Municipal Government of Taytay shall enter into a Memorandum of Agreement (“MOA”) with Land Transportation Office, for assisting in the distribution of Public Motorized Tricycle for Hire License Plates for all Taytayeño constituents;

WHEREAS, this partnership will help decongest high influx of clients at the LTO Taytay Office;

WHEREAS, consistent with the goal of providing Serbisyon May Ngiti to all Taytayeños, the negotiation of MOA with Rizal Provincial Government will strengthen the mission of the Municipal Government to meet the needs of its inhabitants;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH LAND TRANSPORTATION OFFICE TAYTAY, REPRESENTED HEREIN BY ITS CHIEF OF OFFICE, DYONN T. DACPANO, FOR ASSISTING IN THE DISTRIBUTION OF PUBLIC MOTORIZED TRICYCLE FOR HIRE LICENSE PLATES IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER that the duly signed Memorandum of Agreement with the Land Transportation Office - Taytay shall be ratified first by the members of the Sangguniang Bayan before its full implementation.


RESOLVED FURTHERMORE, that a copy of this Resolution be furnished to the Office of the Municipal Mayor, all associated offices and parties concerned for their information and appropriate action.
