WHEREAS, the Municipal Social Welfare and Development Office (MSWDO) has identified and proposed the implementation of a Livelihood Assistance Program for exiting 4Ps beneficiaries and qualified non-4Ps residents to promote economic empowerment and sustainable livelihood development;

WHEREAS, the MAC has determined that partnering with a qualified cooperative will enhance the delivery, management and sustainability of the Livelihood Assistance Program through organized systems of training, financing, and enterprise development;

WHEREAS, the MAC, after deliberation and evaluation, approved Resolution No. 02 Series of 2025, recommending the partnership between the Municipality of Taytay and a duly qualified cooperative to support the implementation of said livelihood program, specifically in areas of fund management, capacity-building, and enterprise development;


